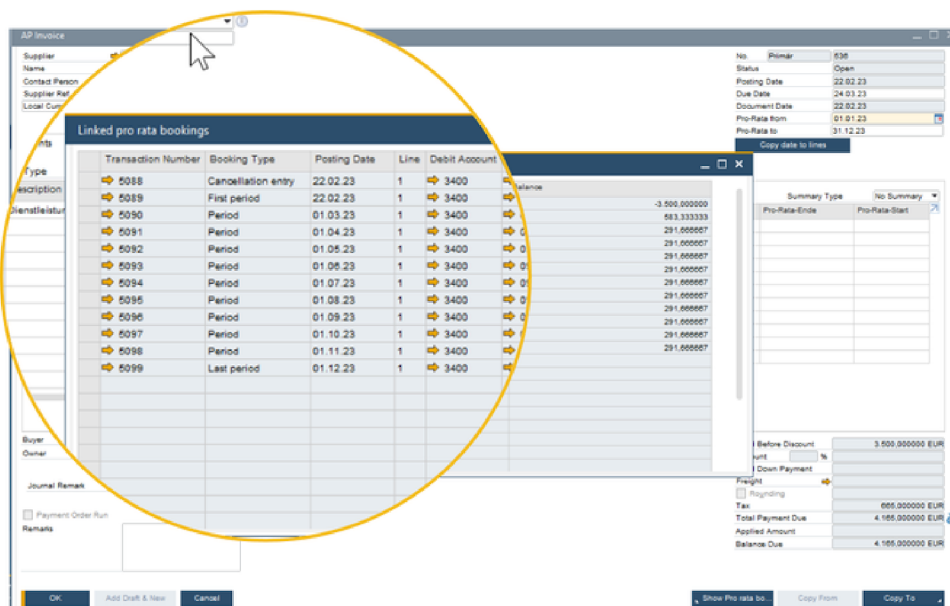

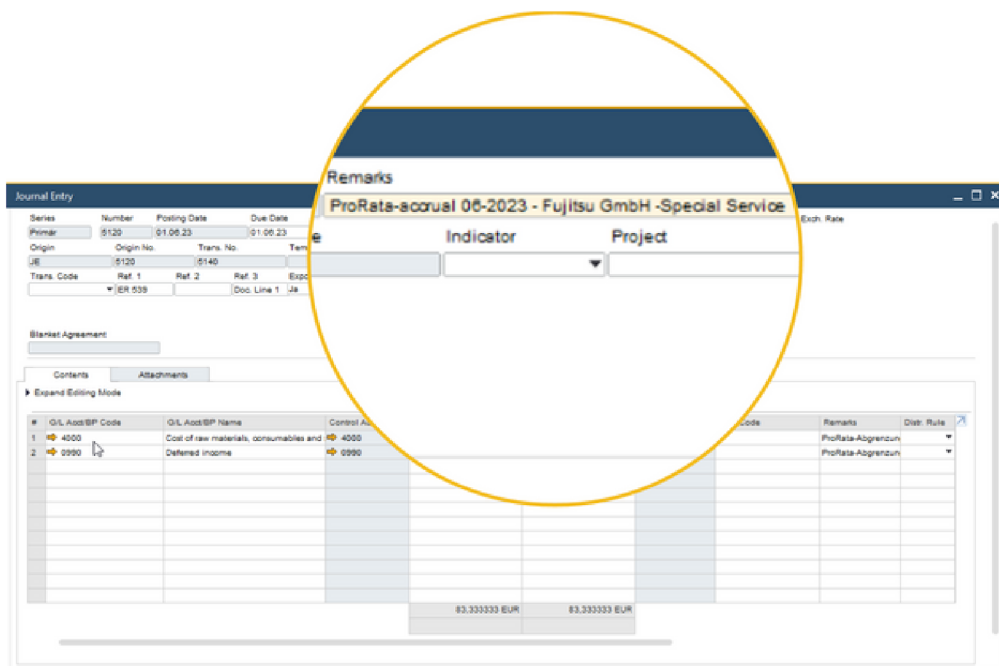
Automatic Accruals Processing

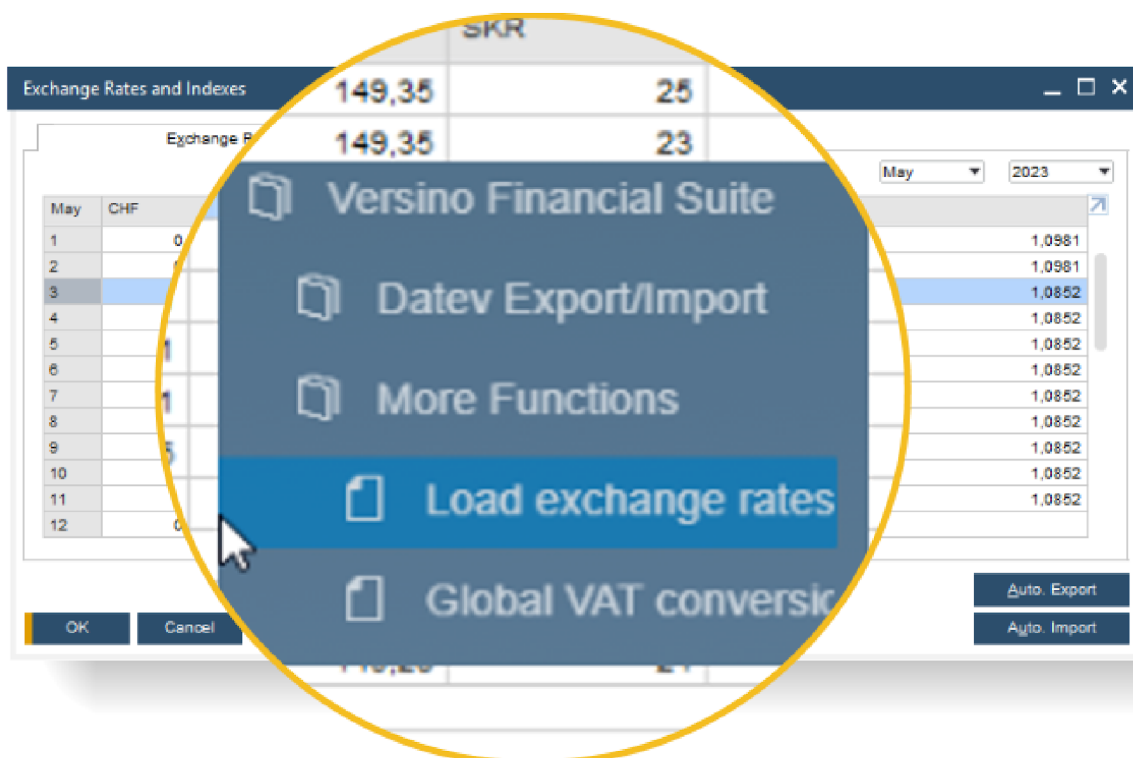
Booking Text Generator

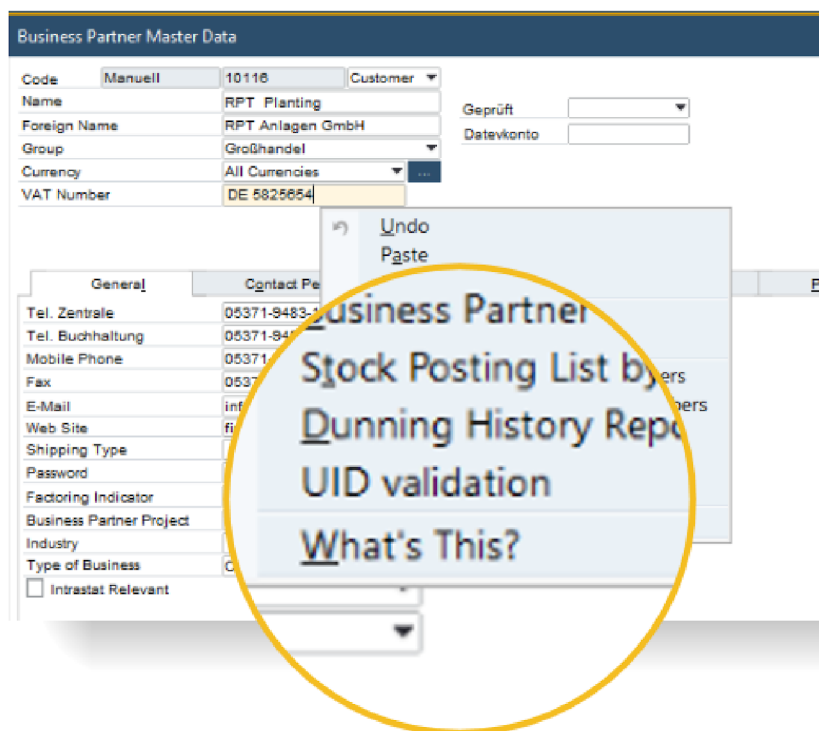


Validation of VAT ID Numbers in Business Partner Master Data

Automatic Generation of IBAN Numbers

Quickly and **easily create valid IBAN numbers**. It is sufficient to simply enter the IBAN number. The suite automatically "disassembles" it and populates the fields for the bank code (BLZ) and account number automatically. (currently works only with German IBAN numbers)
